

For District level committee the member-conveners will be the concerned DDH/DFO/DDA based on the major products of the identified clusters of the districts. Accordingly at present for the identified cluster in **turmeric** in Kandhamal, **DDH** will be the member-convener and for identified **clusters of marine products in Balasore, Bhadrak and Jagatsinghpur** concerned DFO will be the member-convener. For other districts, after identification of production clusters concerned DDA/DDH/DFO will be the member convener based on the major products for export with recommendation of the chairman of the DLC.

The **State Level Monitoring Committee** shall review different activities and issues related to Agri-Exports and **District Level Committee** shall review the cluster development, training on pre and post harvest interventions and identification of bottlenecks for export at district level.


The Committee shall finalise all the issues of Agriculture Export Policy (AEP).
